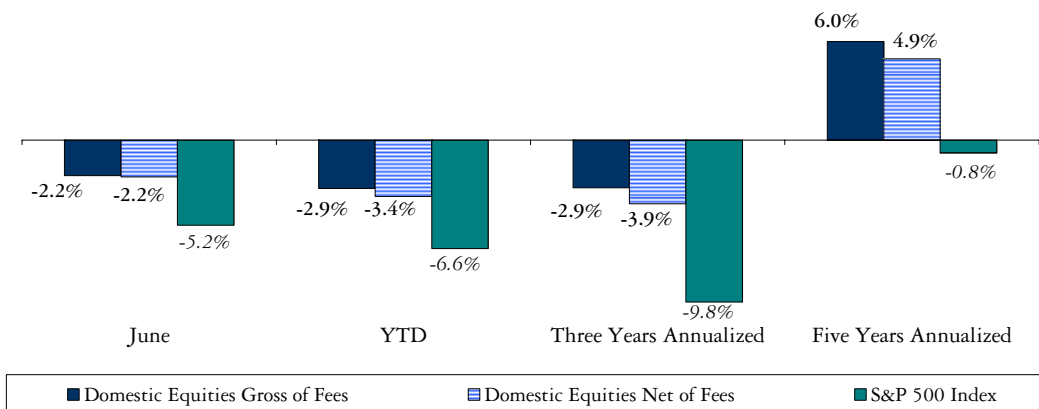

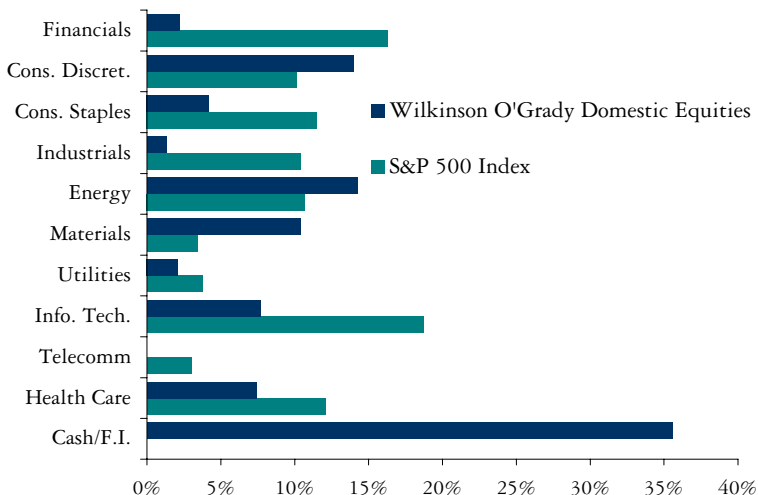
Total Returns
