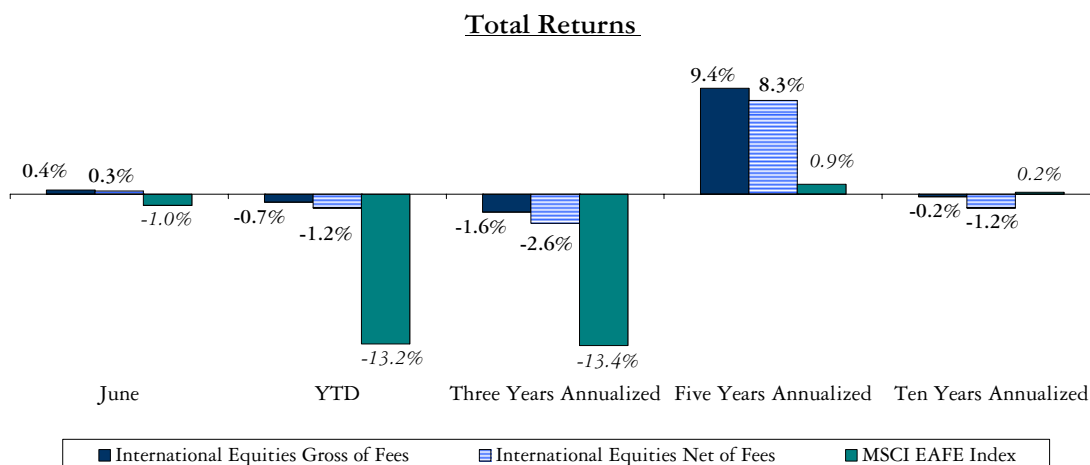

Wilkinson O'Grady manages balanced, equity and fixed income portfolios for individuals, families and institutions. Total assets under management as of June 30, 2010 were \$1,847.1 million. The value of assets in the firm's composites as of June 30, 2010 were: Global Equities - \$828 million (45% of assets under management), Global Balanced - \$484 million (26%), Domestic Equities - \$50 million (3%) and International Equities - \$16 million (1%). Returns are calculated in U.S. dollars. None of the accounts in any composite use leverage. Gross of fee composite performance results are presented before the deduction of investment management fees, but after trading costs. Net of fee composite results assume the maximum 1% management fee charged to clients.
